

Criteria for Registration in Public Health Medicine

Any doctor can request to be registered in Public Health Medicine if he/she fulfils ALL the following requirements:

1. A recognised basic medical degree

- 1.1. A basic medical degree recognized and registered with Malaysian Medical Council.

2. Postgraduate qualification

- 2.1. Recognised postgraduate qualification
 - 2.1.1. Master of Public Health and Doctorate in Public Health / PhD in Public Health from recognised universities
 - 2.1.2. Master of Public Health (4 years course) before the end of 2014
 - 2.1.3. Master of Public Health (less than 4 years course) before end of 2000

3. Any other equivalent Public Health postgraduate degree recognised by the Specialty Subcommittee of Public Health will be considered on a case by case basis.

4. Completed working experience for a minimum duration of 1 year after postqualification experience.

- 4.1. Satisfactory completion of 1 year experience post qualification experience (2.1.1, 2.1.2 & 2.1.3), (maximum leave allowed is 28 days).
- 4.2. Evidence of satisfactory postqualification experience as supported by:
 - Report of Cases of procedures on core competencies.
 - Certificate / Letter of satisfactory completion of training.
 - 2 referee reports from NSR registered Public Health Specialist

5. Work Experience

- 5.1. Curriculum Vitae (CV) showing evidence of:
 - 5.1.1 Training
 - 5.1.2 Experience
 - 5.1.3 Continuous Professional Development (CPD)

6. Notwithstanding the above, the SSC may stipulate any condition, including additional training/work experience/interview, on the applicant if deemed necessary.
